This document shows the transfer of 40-acre parcels in and around the present Donald Park from original owner to next owner and so on to the early 1900s. Parcel numbers are used in place of quarter-quarter sections, that is, of 40 acres in size. Parcel numbers and equivalent 40-acre parcels referred to, for example, as the southwest quarter (SW1/4) of the northwest quarter (NW1/4), or more simply as SWNW, are:
